- Raise achievement and student attainment to the highest academic level

- Liaise with the academic study team in supporting an international student cohort
- Manage student attendance, behaviour in the classroom and on school premises, and apply appropriate and effective measures in cases of missed attendance and misbehaviour in line with School policies

- Work closely with the School's pastoral team and academic study team in order to guide, induct and manage individual learning needs
- Undergo regular lesson observations and participate in regular in-service training (INSET) as part of continuing professional development (CPD)
